Dear Sir

Thank you for your correspondence dated 7 July 2016.

Be advised that Minister Dutton wrote to me on 2 May 2016 on Parliamentary letter head advising that he has forwarded on information to ACLEI, although ACLEI state that "ACLEI is not aware of any information having been received from the Minister (Dutton) in relation to Operation Collage/Bergonia".

A letter also sent by Border Force's First Assistant Secretary Integrity, Security and Assurance Corporate Group, Stephen Hayward on 8 July through Senator Lambie to myself stating that "The department (ACBPS/Border Force) has an established relationship with ACLEI and works collaboratively in the investigation of corruption allegations".

To put it in layman's terms, Border Force says it sharing information and cooperating with you, and ACLEI are stating they have heard nothing from Border Force so someone is clearly lying. ACBPS/Border Force have had ample time to ventilate the unlawfulness and the non-disclosure in Operation Collage/Bergonia but choose not to.

There are very simple things to do to remedy this corruption situation. ACLEI can instruct Border Force to disclose information to me to enable me to obtain information as is legally required for my current legal process, if it is to be in any way legal and fair according to Australian law. This does not hinder any ongoing investigation by ACLEI or Border Force and by continuing to not provide this information is simply further cover ups that should have been lawfully disclosed in 2010.

**1. Disclose all ACBPS/ Border Force Personnel that were present at Scarborough Marina on the 12<sup>th</sup> October 2010 to accused in this biased case. It's an abuse of process due to massive non disclosure and we all know why they were not disclosed. AFP holds a crime scene record that has ALL personnel at the Scarborough Marina on the 12<sup>th</sup> October 2010. This has not been disclosed and has ALL the Customs officer's present at Scarborough Marina on the 12<sup>th</sup> October 2010 names on it. AFP has only provided the crime scene log on the yacht Mayhem of Eden previously.**
